Bidding exercise shall be conducted through Open International Bidding Method procedures.

Bids in sealed envelope clearly marked **Procurement of Dialysis Consumables Kits (Requirements 2017-2019) “MHPQ/MDSP/2016-2017/Q16”** and indicating the closing date should be addressed to the **Chief Executive, Central Procurement Board, 1st Floor, Social Security House, Julius Nyerere Avenue, Rose Hill , Mauritius** and should be deposited in the **Bid Box** at the address mentioned at paragraph 7 or sent by Courier Service or Registered Mail on or before **Thursday 15 June 2017 up to 13.30 hours (local time) at latest.**
6. Electronic bidding shall not be permitted. Late bids will be rejected. Bid shall be accompanied by a **Bid Security in the sum of Rs 1million , or USD 27,500, or EURO 25,950, or GBP 22,600.** Bids will be opened in the presence of the bidder/bidders' representatives who choose to attend at the address given at paragraph 7 as from 14.00 hrs (local time) on the same day.
