Water Ledger, now part of a global parent company, specialises in cutting-edge digital solutions for the water sector. Based in Ireland, the team—of which Benoît is a founding director—has achieved global recognition as the first to successfully tokenise water trades using a distributed ledger approach.

Currently, Benoît plays a leading role in efforts to revitalise South Africa's water sector. As co-founder and CEO of the South African Water Chamber, he is driving initiatives aimed at enhancing water resilience and attracting investment by bridging the expectations of both public and private stakeholders.

He is also a regular contributor to local and international publications and media on issues relating to water, innovation, and sustainability.

Previously, he served as the Chair of the Groundwater Division of the Geological Society of South Africa and as Co-Chair of the International Water Association's Groundwater Restoration and Management Specialists Group. He is deeply committed to human capacity development, exemplified through his mentorship initiatives, research endeavours, and engagement with professional organisations.

Philippa Rodseth is the Executive Director of the Manufacturing Circle. Her career began as an Architect working on commercial projects in South Africa and Hong Kong.
