Booking Instructions

All booking instructions must be made in writing. A signed Order Authorisation or Copy Instruction will be accepted.

Should there be a discrepancy between an Order Authorisation and a Copy Instruction, the details on the Order Authorisation will be binding.

Advertising orders cannot be seen as a confirmation that any editorial submission will be published.

Special positions: No special or specific positions, such as right-hand page placements, can be guaranteed unless

the advertiser agrees to pay a 25% loading fee for such a position.

Cancellations

Cancellations will only be accepted in writing, 45 days prior to the Friday publication date. A 20% surcharge is applicable for any cancellation notifications received within 30 days of the publication date.

Payment Terms

An upfront payment is required for all first-time advertisers, whereafter a 30 days from date of statement payment will be accepted for approved accounts, subject to the completion of Creamer Media's Client Information Sheet.
